The race Organisers shall not be liable for any loss, damage, death or personal injury, howsoever caused, to the owner/competitor, his skipper or crew, as a result of their taking part in the race or races. Moreover, every owner/competitor warrants the suitability of his boat for the race or races.
2. The provision of safety equipment and boats by Parkstone Yacht Club is neither a guarantee that assistance can be rendered to any competitor in need, nor an acceptance of any responsibility for rescue of competitors. Further, in the event that assistance is rendered to any competitor, no liability for any loss, damage or injury to the competitor and/or the boat and its equipment is accepted by either the Club or the crew of such rescue craft.  
  
The attention of all competitors is drawn to R.R.S., Fundamental Rule 4: **“Decision to Race.** A boat is solely responsible for deciding whether or not to start or to continue racing.”
3. It is understood that if the boat is in the charge of any person other than the competitor completing the declaration overleaf, it is this competitor's responsibility to bring the attention of the person in charge of the boat to the provisions of this entry form.
4. **This section must be completed when either owner or competitor is under 18 years of age and to be signed by the person with parental responsibility i.a.w. Childrens Act.**

- d) that the racing Rules of Sailing provide that a boat is solely responsible for deciding whether or not to start or continue racing and that I accept that responsibility.
